Ohio workplace injuries and illnesses below national average

Recently released statistics from the U.S. Bureau of Labor Statistics (BLS) show non-fatal workplace injuries and illnesses in Ohio are below the national average. The 2013 Survey of Occupational Injuries and Illnesses (SOII) found Ohio public and private employers combined for an incidence rate of 3.0 cases per 100 full-time workers compared to the national rate of 3.5. - The Occupational Safety and Health Administration (OSHA) has released two new bilingual -English and Spanish – on-the-job quick references for employers and employees. Tree Care Work: Know the Hazards addresses the most common tree care work hazards and ways to prevent them.
- The Temporary Worker pocket-sized pamphlet reminds individuals working through a staffing agency that they have the same rights as any other worker. The pamphlet is part of OSHA's Temporary Worker Initiative, which focuses on compliance with safety and health requirements when a staffing agency and a host employer jointly employee temporary workers.

OSHA Videos for Construction Safety

The Occupational Safety and Health Administration (OSHA) has 12 educational videos about potential hazards in the construction industry. The educational videos are 2 to 4 minutes long, easy to understand, and geared to the needs of employers and workers. Based on real-life incidents, these videos include detailed depictions of hazards and the safety measures that would have prevented these injuries and fatalities. OSHA's videos cover falls in construction, workers struck by vehicles and heavy equipment, sprains and strains, trenching and excavation hazards and carbon monoxide poisoning.
